#### **ELECTION**

The new Managing Committee (MC)consists of 7 new faces. In the first meeting of the new MC, Smt. Selina Kurian was appointed the Joint Secretary, Shri P.V. Joseph as Treasurer and myself P.N. Venkideswaran Potty as Secretary. The List of present MC is given on page 4.

## ANNUAL GENERAL BODY MEETING

We have successfully conducted our 32nd AGM on 26th September 2021 at MCD Community Centre, Ramesh Nagar, New Delhi. The meeting was held observing Covid-protocols. The President Shri P.R. Nair presided over the meeting and the Vice President Shri Thomas Isac addressed the august gathering.

You may be happy to note that the AGM has decided to reduce the interest rate of loans by 1% and CD by 2%. Hence, with effect from 1-10-21 loan interest has been reduced from 11% to 10% on all existing as well as new loans. In addition, in case of 'Swarna Kalpam' special gold loan to the financial downtrodden members, interest is reduced from 8% to 6% per annum.

Even though the present market value of the gold is fluctuating, we are still maintaining gold loans at the rate of Rs. 3400/- per gram @ 6-10% interest per annum. Needless to say, this will help our members to meet their immediate financial requirements to some extent.

## SPECIAL RECURRING DEPOSIT SCHEMES (SRD)

In order to encourage the saving habits of our members, we have again started accepting recurring deposits for one- and two-year durations @ 6% and 7% interest respectively.

#### **SOFT LOAN**

It is a TATKAL Loan which can be availed by Members who have completed six months and working in Govt./PSU/Limited or reputed companies with good payrolls, for which no surety is required. The maximum limit is Rs. 1,00,000/-.

#### **INTEREST/DIVIDEND**

Like in the previous year, we distributed 8.1% interim dividend, and interest on CD/SDA before Onam and balance 0.9% after AGM. You may withdraw it from SDA if not done so far.

On 1-4-2020 society has recalled all its previous share certificates issued till 31-03-2020 and issued fresh single share certificate in a revised format. #### **ARBITRATION CASES**

The economic instability during the lockdown period has badly affected all sectors of the society. Considering the situation, we had not filed any arbitration cases in the previous year. Defaulters were granted an extended schedule to deposit the dues. But the current ratio of fundinflow reflects the need to step into action to balance the affected factors. Hence, we have filed quite many arbitration OR criminal cases as per u/s 138 of NI Act. The list of such defaulters is given separately in this bulletin.
